The Love INC Vision

Love INC of Clackamas County brings churches, social service agencies and other county non-profits together, to help the poor and needy in Clackamas County. Through an intake and referral clearinghouse staffed by volunteers, we connect people in need with the resources and programs of 45 churches, county and state social service agencies. Each month volunteers dedicate over a 1000 hours to care for the poor through the programs of Love INC. These volunteers take calls from single parent families, the working poor, domestic violence victims, the elderly and the mentally and physically disabled, all of whom have fallen through the cracks of society. The Love INC network connects them with the appropriate church and social service programs to provide things such as furniture and household items, food, clothing and firewood to heat their homes; and with church volunteers who can help with home maintenance and repair, budget counseling, simple companionship, and more.
